The accumulative number of days that an individual who has no domicile but has resided in the territory of the China mainland should be counted according to the accumulative number of days that the individual has been present in China mainland in the tax reporting year. A day with full 24-hour presence is therefore counted in, a day with less than 24-hour presence is not counted in.
