## 1.Part 1 – Identification of Individual Account Holder

- **A.Name of Account Holder:** Insert your name on your identity document, such as the name on your National ID Card or passport which is provided to the Bank.
- B.Date of Birth: Write down your date of birth using dd/mm/yyyy format.
- **C.Place of Birth:** Please provide your city of birth and country of birth.
- D.Current Residence Address: Breakdown your full address in different fields as specified in the form.\*
  - \*DO NOT USE: PO Box or C/O address, Address of a third party, Address at a Financial Institution
- E.Mailing Address: Please only complete if different to the address shown in Section D.

## 2.Part 2 – Country/Jurisdiction of Tax Residence and related Taxpayer Identification Number ("TIN") or functional equivalent

This number depends on which country you are tax resident. If you are a local tax resident, the TIN should be National ID Card Number or Uniform ID Number.

The OECD has provided some information on the acceptable numbers and format. If you cannot provide a TIN, please indicate the reason A, B or C on the form. If you select reason B, please provide a written reason for not being able to provide the TIN. This must be written in the table on the form.

## 3.Part 3 - Declarations and Signature

You must be the individual identified in Part 1 (or the legal guardian of the Account Holder who is a minor).

- **A.**Please sign the form. The signature should match with the Bank's records.
- B.Please date the form using the dd/mm/yyyy format.
- C.Please print your name.
- **D.**If you are legal guardian of the Account Holder who is a minor, please indicate the capacity in which acting.
